OEUH is an exchange traded fund (ETF) that seeks investment performance that correlates generally to price and yield before fees and expenses of the FTSE Developed Europe Qual/Vol/Yield/5% Capped Factor Hedged 100% to USD Index.

### Why OEUH?

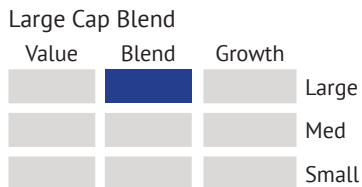
OEUH provides a simple, cost efficient and transparent way for investors to own a portfolio of companies and investment strategy that adheres to our core investment principles:

## What's the difference between OEUR and OEUH?

The O'Shares FTSE Europe Quality Dividend Hedged ETF hedges against fluctuations in the relative value of foreign currencies in which O'Shares FTSE Europe Quality Dividend Hedged ETF Target Index's components are denominated against the U.S. dollar. Thus, it is designed to have higher returns than an equivalent fund that does not hedge against a weakening of such foreign currencies relative to the U.S. dollar. Conversely, the O'Shares FTSE Europe Quality Dividend Hedged ETF would be expected to have lower returns than an equivalent unhedged fund when these foreign currencies are rising in value relative to the U.S. dollar.

## Index Methodology

The FTSE Developed Europe Qual/Vol/Yield/5% Capped Factor Hedged 100% to USD Index (FDEQVY5H) is designed to reflect the performance of high quality Large and Mid Cap equities across the Europe region that exhibit relatively low volatility and high dividend yields. Constituents are selected and weighted based on Quality, Volatility and Yield characteristics. The Europe Hedged Target Index hedges against fluctuations in the relative value of foreign currencies in which the Europe Hedged Target Index's components are denominated against the U.S. dollar. Thus, it is designed to have higher returns than an equivalent index that does not hedge against a weakening of such foreign currencies relative to the U.S. dollar. Conversely, the Europe Hedged Target Index would be expected to have lower returns than an equivalent unhedged index when these foreign currencies are rising in value relative to the U.S. dollar. The Europe Hedged Target Index applies published one-month currency forward rates to the Europe Hedged Target Index's total foreign currency exposures to adjust the value of the foreign currencies against the U.S. dollar. The Fund intends to enter into forward currency contracts or futures contracts to effectuate the hedging strategy embedded in the Europe Hedged Target Index. Although the hedge nature of the Europe Hedged Target Index is designed to minimize the impact of currency fluctuations on returns, it does not eliminate the Fund's exposure to foreign currency fluctuations.
