


Small-Cap Stocks: Dividend Quality Could Be the Key to Finding Potential Winners

Looking for Potential Winners: Russell 2000 dividend paying stocks in the 1st quartile of dividend growth had an average annualized return of over 6% over the last 5 years.

Lower Growth, Lower Returns: 4th Quartile companies by dividend growth generated negative returns on average over the last 5 years.

1st Quartile: Contains the top 25% of companies in the Russell 2000 based on average 5-year dividend growth. **2nd Quartile:** Contains the top 25%-50% of companies in the Russell 2000 based on average 5-year dividend growth. **3rd Quartile:** Contains the top 50%-75% of companies in the Russell 2000 based on average 5-year dividend growth. **4th Quartile:** Contains the bottom 25% of companies in the Russell 2000 based on average 5-year dividend growth.

Dividend Growth: Growth rate over five years in net dividend per share.

Russell 2000: Represented by the Russell 2000 Index. The Russell 2000 Index is comprised of the smallest 2000 companies in the Russell 3000 Index, representing approximately 8% of the Russell 3000 total market capitalization.
