Seeks less volatile approach to invest in small cap companies.

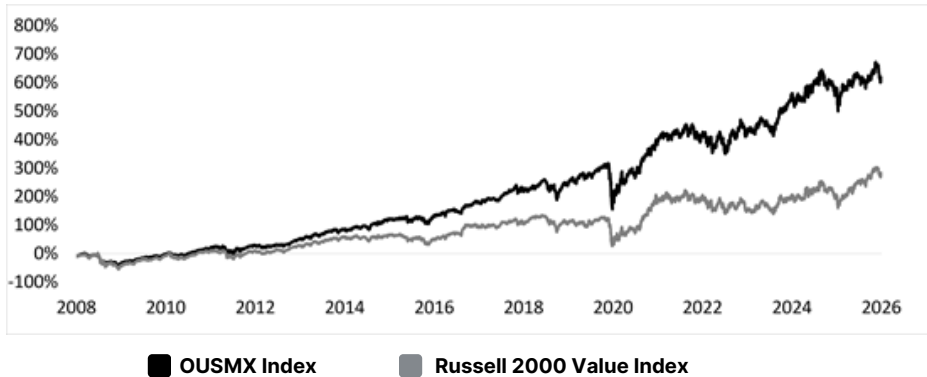

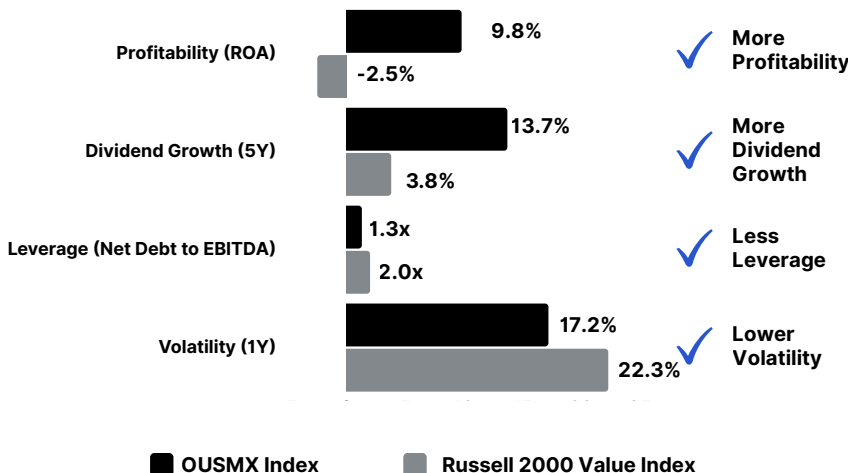
