O'Shares U.S. Small-Cap Quality Dividend ETF (OUSM) is designed to be a core investment holding, providing cost efficient access to a portfolio of small-cap, high quality, low volatility, high dividend paying companies in the United States selected based on fundamental metrics including:

QUALITY • LOW VOLATILITY • DIVIDEND YIELD

OUSM is an exchange traded fund (ETF) that seeks to track the performance (before fees and expenses) of the O'Shares U.S. Small-Cap Quality Dividend Index ("OUSM Target Index").

Why OUSM?

Quality Dividend Stocks: Seeks small-cap companies with strong balance sheets, profitability and dividend quality.

Performance: Aim to provide strong performance with less risk than a market-cap weighted approach.

Reduced Risk of Yield Traps: Emphasis on dividend quality to help avoid dividend cuts and suspensions.

The method box reveals a fund's investment strategy. For the equity holdings in the fund's portfolio, the vertical axis shows the market capitalization of the stocks owned and the horizontal axis shows investment style (value, blend or growth).

O'Shares U.S. Small-Cap Quality Dividend Index (OUSMX) is designed to reflect the performance of publicly-listed small-capitalization dividend paying issuers in the United States exhibiting high quality, low volatility and high dividend yields as determined by O'Shares Investment Advisers, LLC. The quality and low volatility requirements are designed to reduce exposure to high dividend equities that have experienced large price declines.
